How the portal works

- Input An online web portal is integrated to the client website. Suppliers enter their information into the online portal. The form is dynamic, asking further questions based on the inputs on the supplier. Suppliers can categorize themselves according to the client's spend categorization and upload supporting documents into the Portal.
- Process Al generates a case with all supplier data and documentation provided. Workflow checklists drive the case through a defined process. Outbound docs can be created and sent to suppliers from within the central system. This system acts as a centralized database.
- Output Visualize the imporved suppl:ier data in dashboards to understand spend and the risk associated. The improved supplier data removes the need for manual categorization of the information before it can be used in dashboards. Different dimensions can be selected to provide a wide range of insights from the data e.g., tail-end spend and opportunities for supplier rationalization.

- Speed up supplier registrations The selfservice portal enables prospective suppliers to upload supporting documentation (e.g., ISO certifications, supplier catalogues, etc.) without relying on procurement support.
- Validate prospective suppliers against external databases Improve the quality of supplier data for processing, reporting and analysis by using third-party data e.g., Dun & Bradstreet or Experian.

 documentation when required.
- Reduce the risk of supplier fraud The robust onboarding process facilitated by the portal ensures a consistent approval process for new suppliers across your organization.
- Boost your spend visibility Automatically categorize your suppliers at the point of onboarding and feed your validated and complete data into your ERP system.
